Dear Vaisnavas,

Please accept my humble obeisances. All glories to Srila Prabhupada.

As a small step towards introducing within ISKCON a higher degree of personal financial accountability and transparency, since 2002 I have published an annual account of my finances. I here publish my finances for the year 2006.

This is not an account of my personal income and expenses, especially not in any legal sense. Rather, it is an account of money that has passed through my hands (and some that is still in them). Especially in accounting for expenditures, I have used terms like "Donation" merely as a matter of convenience. The money that came to me was not mine, so who was I to "donate" it? Often, in fact, the money came in the form of checks made out to ISKCON, the BBT, or a related organization, and all I did was receive them and pass them on.

In any case, I believe that these funds ought to be accounted for and that the accounts ought to be available to whoever may find them of interest. And so I am making them public.

I pray for the blessings of all well-wishing Vaisnavas that anything I receive by the grace of Laksmi may always be properly offered at the lotus feet of Lord Narayana.
